# CONSTITUTIONAL CHARTER AND CODICE OF THE SOVEREIGN ORDER D'MEYEERS

*officially effective the twenty-third day of March in the year of our Lord two thousand and twenty-four.*

## PART I CONSTITUTIONAL NOTICE

This **Constitution** is **legal** and its contents are to be interpreted literally. Once **notified**, it is formally registered, and will be published in the local public records to ensure its general and official knowledge.

After a cure period of **twenty-one days** from the date of notification, in the name of our Lord, this **Constitution** shall prevail as a legitimate and binding document, in accordance with **ratified international agreements** and under the authority of the **Common Law**.

### OF THE ORIGIN AND NATURE OF THE SOVEREIGN ORDER DI: MEYEERS

The Sovereign and Mystic Order Di: Meyeers© was born on July 03rd of the year of our Lord 1693, in the heart of the Great Di: Meyer© a German Native of pure blood, arose a group of humanitarians who created the first hospital in Germany to start international hospital and humanitarian missions at the beginning of the XVII century. The benefits of such a work for the living Man and Woman were immense such as the healing of all diseases by means of millenary techniques and customs known to the Great G: Meyeers and his group of humanitarians. From there the information has been passed on to all the future descendants of the Great G-d: Meyer that were more than eight generations of mystical knowledge and also of all that is connected with the individual Sovereignty, and we arrive to the present with the legal structuring of the Order in order to protect the secular traditions through the use of the tools available in the international agreements and as dictated by this constitutional charter and codex.



The organization in the territory of the Nations in which the Order exercises its activity as an independent Sovereign State with unlimited rights, and each Sovereign of the Order enjoys

Diplomatic status according to the Vienna Convention and Sovereign State by virtue of international rights or agreements.

The Sovereigns of the Order Di: Meyeers can create, following the rules of the Code, an independent entity, in accordance with the national laws and the international conventions and agreements made with the Nations, in order to be able to carry out its institutional and/or commercial activity.

#### **PURPOSE OF THE ORDER DI: MEYEERS**

In honor of the secular traditions, the Di: Meyeers Order has the purpose of promoting the truth that God has left us through the development of the conscience of its members and through humanitarian aid to help those in need.

Faithful to the Divine principles and the counsels of Our Lord Jesus Christ of Nazareth, guided by the teachings of the Di: Meyeers Order.

#### **OF THE SOVEREIGNTY OF THE DI: MEYEERS ORDER**

The Sovereign Order Di: Meyeers© declares itself a Sovereign State and administrator and/or representative subject of international law exercising Sovereign functions.

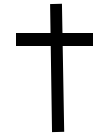
The legislative, commercial, executive and judicial functions are reserved to the competent bodies, according to the provisions of the Constitutional Charter and the Codex.

### **OF THE SUPREME COURT OF THE ORDER**

The **Sovereign Order Di: Meyeurs©** , in exercise of its sovereignty and in conformity with the  
**Divine Natural Laws** and the principle of **Free Will**, establishes the following provisions  
regarding its **Supreme Tribunal**:

#### **Own Legal System**

The Order reserves the exclusive right to:

- Create, develop and operate its **own sovereign legal system**, independent of any external  
jurisdiction.



- To ensure that the Supreme Court of the Order administers justice in accordance with its principles and **Constitutional Charter**.

## 2. Judgment of Members

The **Supreme Court** has the exclusive authority to judge any of its members, respecting at all times:

- The **Divine Natural Laws**, which govern creation and existence.
- The principle of **free will**, guaranteeing individual freedom and respect for the decisions of each member.

## 3. Restoration and Integral Balance

The Order declares its commitment to the welfare of its members, and reserves the right to:

- To help **restore the physical, mental and spiritual balance** of any of its members.
- Use **advanced quantum restoration techniques** that address all areas of life, including **financial life**.

## 4. Prohibition of Deprivation of Liberty

The Order declares that it will never grant the right, under any circumstances, to **deprive** any of its members **of their liberty**, since such action:

- It violates the **Laws of Free Will**, recognized as a universal and inviolable principle.
- It goes against the fundamental principles of respect, dignity and individual sovereignty that the Order promotes.

These provisions ensure that the **Supreme Court** of the **Sovereign Order Di: Meyeurs©** acts with justice, integrity and respect for its members, always promoting balance, freedom and well-being in all aspects of life.

## OF THE STATUSES ISSUED TO THE MEMBERS OF THE ORDER

The **Sovereign Order Di: Meyeurs©**, by virtue of its sovereignty and international law, declares and reserves the exclusive right to **issue and recognize specific statuses** for its members. Such statuses include, but are not limited to:

1. **Diplomatic:** Recognition with diplomatic status in accordance with the principles of the **Vienna Convention** and applicable international treaties.
2. **Privileged Creditor:** Recognition of privileged financial and property rights according to the provisions of the Order.
3. **Subject of International Law:** Status that allows acting in accordance with the principles and norms of international law.
4. **Citizen and PERSON:** Issuance of internal citizenship and recognition of legal personality under the applicable legal systems.
5. **Other Statuses:** The Order reserves the right to create and issue new statuses in accordance with the developments of international treaties and agreements ratified in the future.



## COPYRIGHT OF THE MEMBERS OF THE ORDER

The **Sovereign Order Di: Meyeurs©** declares and reserves the exclusive right to manage the **copyright** of its members under the following conditions:

### 1. **Application of Common Law:**

Copyright shall be granted in accordance with the principles of the **Common Law** for all members of the Order, either by:

- **Direct descendants** of the Di: Meyeurs. ○ **Express invitation to join the Order.**
- **Self-determination**, accepting the principles of the Constitutional Charter and the Codex.

### 2. **Registration Processes:**

- The copyright registration processes will be **automated** and managed through the **legal, public and archiving system** of the Order©.
- The Order shall guarantee the integrity, protection and validity of the copyright issued to its members.

### 3. **Verification and Diplomatic Representation:**

If **verifications or certifications** are required, shall:

- Notify the Order© directly. ○ The Order shall assign an **Authorized Representative** to carry **out diplomatic missions**, ensuring respect and recognition of copyright in any jurisdiction. These provisions reaffirm the capacity of the **Sovereign Order Di: Meyeurs©** to protect and regulate the rights and status of its members, in accordance with national and international laws, ensuring the sovereignty and autonomy of the Order in all its processes.

This position will be updated and formally reflected in the Order's Constitution of 2025, reaffirming our commitment to peaceful coexistence and respect for international law.

## **OF THE OFFICIAL NATIONAL HINO, MANTRAS AND MUSIC OF THE ORDER©.**

The Sovereign Order Di: Meyeurs© chooses any sacred mantra that generates a good yantra or harmonic effect on the Living Being.

The Order© advises members to reduce exposure to any music or frequency that is not Harmonic and Sacred.

The Order© does not accept the induction of subconscious sounds to its members, nor brainwashing in any of its forms, if the Order© detects any of its members with that style or



any other form of control and coercion, also if we detect a public or private order to execute or kill without the due authorization of the Sovereign Council, the executor of the act and/or creator of the control system will be taken to the Supreme Court and there will be consequences for the violation of the ratified international agreements.

## **STATEMENT OF RATIFIED INTERNATIONAL AGREEMENTS**

*Vienna Convention: The Vienna Convention on Diplomatic Relations is an international treaty regulating diplomatic relations between countries and the immunity of diplomatic personnel. It was adopted on April 18, 1961 in Vienna and entered into force on April 24, 1964.*

*Montevideo Convention: The Convention on the Rights and Duties of States, better known as the Montevideo Convention, was the Seventh International Conference of American States inaugurated on December 3, 1933 and concluded on December 26, 1933 with the international treaty signed in Montevideo, Uruguay.*

*Berne Convention: The Berne Convention, which was adopted in 1886, deals with the protection of works and authors' rights. It offers creators such as authors, musicians, poets, painters, etc., the means to control who uses their works, how and under what conditions.*



Customary Law: *That is a set of customs, practices and beliefs accepted as binding rules of conduct.*

UDHR - Human Rights: *The Declaration establishes, for the first time, the fundamental human rights that must be protected worldwide and has been translated into more than 500 languages.*

Among other similar rights as long as they do not violate the principles of Natural Law.

The Flag of the Order is of Red color with a Cross of Jesus Christ of Nazareth in Black on its Left side, symbolizing the Black Cube that opens when it evolves and forms a Cross as it is explained very well in several of the exoteric teachings.

The Sovereign Order Di: Meyeers© reserves the rights to design, administer, print, certify and distribute everything related to the Identification of its Members.

The Sovereign Order Di: Meyeers© complies with all ratified international treaties and also with the advice of the competent bodies such as the UN, INTERPOL and Civil Aviation.

## **OF THE POWER OF THE MEMBERS OF THE ORDER**

The Order© has Authority and declares that all members initiating with the Order© will break all forms of management of the vital energy of the Living Being including the CEST QUE VIE TRUST.

The Order© reserves the right not to accept any known or unknown procedures that absorb, control or manage the energy of any of the members of the Order©.

## **OF THE GOVERNMENT OF THE**

### **THE GREAT MASTER**

To the Grand Master as the Leader of the Order, correspond the prerogatives and sovereign honors.

**OF THE REQUIREMENTS FOR THE ELECTION TO GRAND MASTER**

- Paragraph 1 - The Grand Master is elected for life by the Plenary Council of State from among the Sovereigns, with at least ten years of Development of Conscience.
- Paragraph 2 - The Grand Master and the Grand Master's Lieutenant must possess the nobility requirements prescribed for the class of Honor and Conscience Development.
- Paragraph 3 - The election of the Grand Master is communicated to all the Members of the Order Di: Meyeurs, taking office, by letter of the elected.

**THE SOVEREIGN COUNCIL**

- Paragraph 1 - The Sovereign Council assists the Grand Master in the government of the Order.
- Paragraph 2 - They are part of the Sovereign Council: the Grand Master or the Lieutenant, who presides over it; the representatives of the four Senior Officers and six Board Members.
- Paragraph 3 - The members of the Sovereign Council, with the exception of the Grand Master and the Lieutenant, are elected by a majority of those present.
- Paragraph 4 - The Grand Commander and at least four other members of the Sovereign Council must be adequate and have control of their Ego through the development of consciousness.
- Paragraph 5 - For the admission of members belonging to the first class, only those members of the Sovereign Council are entitled to admission to the Sovereign Council who to be Self-Determined Sovereigns.
- Paragraph 6 - The members of the Sovereign Council remain in office until the end of their term of office.  
The General Chapter and can be reelected. For a third or successive subsequent consecutive re-election to the same office, the following is required majority of two thirds of the votes of those present.
- Paragraph 7 - The Grand Master does not participate in the voting on matters in which the



The Sovereign Council has a deliberative vote or must express an opinion, 19, paragraph 3, shall remain unchanged.

In the event of an equal number of votes among the Board Members, including the Senior Officers, the Board of Directors shall

In the case of a charge, the Grand Master's decision is final. If the Grand Mestre expresses no opinion, the matter is considered in abeyance.

The Order© provides for the rights of all its members to self-government with unlimited responsibilities.

Read and accept, under solemn oath, what is written in the **Constitutional Charter of the Order** and the **Natural Laws** that govern the same.

3. **Financial Contribution:**

Make a contribution of **650,000 units** of the most valuable fiat currency at the time of entry (USD, EUR or other that may arise in the future).

- Payment should be made **exclusively in cryptocurrencies**, as a means of support and sustainability for the projects and objectives of the Order.

### INTERPRETATIONS

Order Di: Meyeers© : Here I refer to a religion that claims to defend the inalienable freedom of the Soul that dwells in every Living Man and Woman.

Living soul: means a living being as described in the Book of Genesis, Chapter 2:7.

Genesis: is the beginning of the Earth and of Time itself.

surety: means one who is primarily liable for the payment of another's debt or the performance of another's obligation, namely, one who becomes a joint and several obligor, the terms of the undertaking being identical to those of the other obligor, and the circumstances under which the joint and several obligation is assumed being such that, if the joint obligor is compelled to pay anything, he will be entitled to a full refund. - Black's Law Dictionary, 11th ed (2019).

Sovereigns of the Di: Meyeers Order: Refers to all Men and Women Alive in spirit who decide of their own free will to learn and teach according to the knowledge base of the Di: Meyeers Order© which is under protection of Intellectual Property,



Copyright, Commercial Registry as Privileged Creditor, Sovereign Status and more documents that are Private but will be presented in due time if needed.

Temple: It refers to what we know as the body of flesh, blood, bones and millions of micro-lives that is the conduit that God our Lord has created so that the Eternal and Immutable Soul can interact with that reality of the third dimension , it also refers to the ground where the Sovereign is treading at that moment as his house or any other private property.

## PART DECLARATION

*Let it be known to all my fellow men of the Earth upon which I stand, that I: **Great-Di: Meyeer©** have declared myself to be a man, a living man liber intervivos, a living Soul and sentient being as described in Genesis 2:7, a Sovereign, and a Beneficiary of the Life bestowed upon me by God. I am of sound*



*mind and competent to mind my own affairs and do so in good faith and to the best of my knowledge*

*and belief, therefore, I hereby declare the creation of the Order Di: Meyeers© to be officially effective this twenty-third day of March in the year of our Lord two thousand and twenty-four.*

1. All self-determined Sovereigns of the Di Meyeers© Order accept the laws of nature, also known as the law of the land, and reserve all inalienable rights and freedoms guaranteed by it. They will always resort to the pen to resolve any issue before considering the use of physical force. However, they reserve the right to defend their home, their family, their private property, their rights and liberties, and their lives from harm and evil, using only such reasonable force as may be necessary. They also reserve all rights without prejudice and without waiver of any, including the right to equity and equitable redress. The lands of this Earth have been secured in trust by God to Adam, his heirs and successors forever, therefore, every Living Man and Woman is entitled to and cannot be stripped of his or her nationality as a settler and inhabitant of the lands of Origin. As man and woman on Earth, we are born with free will to choose our own destiny. Therefore, we all have the right to self-determination. The Sovereigns of the Di: Meyeers© Order protect and cherish this God-given privilege for the rest of their days. Along with the appellations used above to describe likeness, by birthright. Any implied right of access to where a Sovereign of the Order Di: Meyeers© calls home, or physical space, as well as any property is revoked and removed indefinitely. Trespassers enter at risk of fines and prosecution. And also they will not be subject to the violation of the Temple/Divine Body with nano-technologies et similia et idem sonans or other direct or indirect procedures such as vaccines and genetically modified foods or anything that arises in the future that relates to that.
2. All those who determine themselves Sovereign of the Di Meyeers© Order accept the laws of the Air ("heir"), known as the law of trust or ecclesiastical law. They will vow to always remain in honor of their oaths and obligations, and to live my life in good faith. As man, living Soul and beneficiary of Life, accepting unconditionally and wholeheartedly the Life granted to you by God, the Earth and all that is therein to prosper, and the Rights, Freedoms and Liberties guaranteed along with it. They accept therefore all the benefits as well as all the responsibilities that accompany this grant of life. They will live their life under the principles of Love thy neighbor and Do no harm to any conscious living being. They accept also the conditions of Life, which we recognize as The Ten Commandments engraved on two tables of stone and brought to the people by Moses of Israëï.
3. Lasty, All self-determined Sovereigns and Sovereigns of the Order of Di Meyeers© accept water law. There are many names for this body of law; maritime law, admiralty law, mercantile law, lex mercatoria, commercial law, law of the sea, international law, and so on. A Sovereign of the Order of Di Meyeers© stands above the water as a man or woman on land. © As a man or woman, a Sovereign of the Di Meyeers Order© has the capacity to captain a vessel that will serve as a conduit for the operations and functions of commerce. Its activity is strictly private, identifiable in commerce as a sovereign state with its own court of office records and enjoys diplomatic immunity as declared in the 1961 Vienna Convention on Diplomatic Relations and wishes to be recognized and treated as such by all public agents/trustees and all other international and national corporate bodies, persons, agents and member states. In no event shall a Sovereign and Sovereign of the Di Meyeers Order©



be considered a surety or accommodating party to any trust, corporation or any other legal person or vessel against any and all claims, legal actions, guarantees, judgments, demands, liabilities, losses, depositions, summonses, demands, costs, fines, liens, attachments, levies, penalties, damages, interest and expenses of any kind, both absolute and contingent, now existing and hereafter arising, which may be suffered or incurred by, as well as imposed upon, for any reason, purpose or cause, such trust, corporation or any other legal person.

4. Every Sovereign of the Di Meyeurs Order© further declares that they are not a corporation, trust, body politic, juridical person, homo stramineous, or ens legis in any way. Their status and standing shall not be diminished capitis diminutio maxima. In written communication, conveyed as fact by use of correct sentence structure, communication, parse, syntax, grammar and copyright protect the legal name so that the Sovereign of the Order of Di Meyeurs© has protection against malicious commercial events or occurrences and fraudulent presentations in commerce. Every Sovereign of the Di Meyeurs Order© is also self-determined to be a man or woman of competent ability and intellect. Further, they are in no way a servant, citizen, taxpayer, employee, person, officer, agent or other authorized representative of HIS MAJESTY THE QUEEN dba HIS MAJESTY THE KING, or any other body politic, both known and unknown, and operating as a de facto governmental entity, principal or subsidiary person of such entities anywhere on Earth, in the Universe and in the Spiritual Realm. Every Sovereign of the Di Meyeurs Order© reserves the right to enter into a contract with the various Peace Officers, as well as any Navy, Air Force, Space Force, Intelligence Service and Army to defend his or her status as a public servant and agent of Peace under oath, in the event of a breach of the peace. Every Sovereign of the Order of Di Meyeurs© grants his or her explicit consent to said servicemen and women to assist in safeguarding his or her sovereign status and all that is set forth in this constitution. They have sworn no oath other than that solemn oath to our Lord God Almighty and pledge allegiance to Him alone and to His Son, our Lord and Savior Jesus Christ. They swear to live their lives under the precepts of Love thy neighbor and Do no harm to any living conscious being.
5. The Sovereigns of the Order Di: Meyeurs© have the right to choose any legal status as PERSON, Citizen, Privileged Creditor et idem, existing at present and any that may arise in the future.
6. The Sovereigns of the Order Di: Meyeurs© should not interfere directly in the affairs of other Sovereigns, CORPORATIONS, Countries, PEOPLE, Citizen, et similia et idem sonans, because all Living children of God have the right of Free Will and therefore are in the right to do what they want as long as there is a MUTUAL ACCEPTANCE between all parties involved.
7. The Sovereign of the Di Meyeurs© Order must never identify in a compulsory way with the gender nor with the Temple/Body given by our Lord God Creator of Galaxies nor much less with flags, Nations or any other form of network of collective thoughts and enslavement of the Eternal and Free Soul by Nature.
8. We only accept Private Education dictated in Codex-33 which is private and is the foundation of the learning of the descendants of the Sovereigns and Sovereigns of the Di Meyeurs Order©.
9. The diet of the Sovereigns of the Di Meyeurs© Order must be only and strictly as dictated by the Creator God Himself, being thus only food compatible with the Natural DNA of the Living Man or Woman which is decided by each Sovereign and no rule created in the past, present or future can prevent a Sovereign to buy, trade, exchange et idem, in order to



keep intact, clean and as Sacred as possible the Temple/Body.
